

I-2. Hardware Overview

Front Panel

The front panel of the switch consists of:

- 8 x 10/100/1000Mbps RJ-45 Ports
 - Ports 1-8 are PoE Capable
 - Ports 9-10 are SFP transceiver Capable
- A Series of LED Indicators

I-3. LED Indicator

Power/SYS:

LED Status	Mode	Description
Croop	On	Power on
Green	Blinking	System boot-up
Off	Off	Power off or fail

Link/ACT:

LED Status	Mode	Description
Green	On/Blinking	1000Mbps connected/data transmitting
Amber	On/Blinking	10/100Mbps connected/data transmitting
Off	Off	Disconnected or fail

PoE Max:

LED Status	Mode	Description
Green	On	PoE power output is over 120W PoE power budget
Off	Off	PoE power output is under 120W PoE power budget



I-4. Desktop Installation


Install the switch on a desktop by attaching the cushioning rubber feet to the bottom corners of the switch to protect against external vibration. Allow adequate space for ventilation between the device and any objects around.



I-5. Rack-mounting Installation


The switch can be mounted in an EIA standard-sized 19-inch rack that can be placed in a wiring closet with other equipment. To install the switch, please follow these steps:

1. Attach the mounting brackets on the switch's side panels (one on each side) and secure them with the screws provided.

2. Use the screws provided with the equipment rack to mount the Switch on the rack and tighten it.





II-1. Switch to End Device

1. Connect the switch to local power with the included power cable.

2. Use a standard Cat 5/5e Ethernet cable to connect the switch to end devices as shown below. Switch ports will automatically adjust to the link rate of the device to which it's connected.


Optionally, any port can be used to uplink to an existing network.

II-2. Login

- 1. Open a web browser and go to the switch's IP address.
- 2. Enter the access point's default IP address **192.168.169.1** into the URL bar of a web browser.
